Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> ■ Social Security number, income, account balances, assets, investment experience, account transactions, risk tolerance, retirement assets, and employment information. <p>When you are no longer our customer, we continue to share your information as described in this notice.</p>

How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons LOVELESS WEALTH MANAGEMENT LLC chooses to share; and whether you can limit this sharing.

What we do

How does Loveless Wealth Management LLC protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

Loveless Wealth Management LLC also requires nonaffiliated third party service providers and professional consultants to agree and adhere to the requirements set forth in Non-Disclosure Agreements.

How does Loveless Wealth Management LLC collect my personal information?

We collect your personal information, for example, when you

- open an account; seek advice about your investments; direct us to buy securities, direct us to sell your securities, enter into an investment advisory contract, give us your income information; provide employment information; tell us about your investment or retirement portfolio; tell us about your investment or retirement earnings; provide account information; give us your contact information; make a wire transfer; tell us who receives the money; tell us where to send the money; show your government-issued ID; and show your driver's license.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes – information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- **Loveless Wealth Management LLC has no affiliates.**

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- **Loveless Wealth Management LLC does not share with nonaffiliates so they can market to you.**

Joint Marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- **Loveless Wealth Management LLC does not jointly market.**
