What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> ■ social security number ■ income and employment information ■ account balances, account transactions, and wire transfer instructions ■ assets, investment experience, risk tolerance, and retirement assets <p>When you are no longer our customer, we continue to share your information as described in this notice.</p>

How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons LOVELESS WEALTH MANAGEMENT LLC chooses to share; and whether you can limit this sharing.

How does Loveless Wealth Management LLC protect my personal information?	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</p> <p>Loveless Wealth Management LLC also requires nonaffiliated third party service providers and professional consultants to agree and adhere to the requirements set forth in Non-Disclosure Agreements.</p>
How does Loveless Wealth Management LLC collect my personal information?	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> ■ open an account, provide account information ■ seek advice about your investments, enter into an investment advisory contract ■ direct us to buy securities, direct us to sell your securities ■ give us your income information, provide employment information ■ tell us about your investment or retirement portfolio, tell us about your investment or retirement earnings ■ make a wire transfer, tell us who receives the money, tell us where to send the money ■ give us your contact information, show your government-issued ID or your driver's license
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> ■ sharing for affiliates' everyday business purposes – information about your creditworthiness ■ affiliates from using your information to market to you ■ sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p>

Definitions

Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <p>■ Loveless Wealth Management LLC has no affiliates.</p>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <p>■ Loveless Wealth Management LLC does not share with nonaffiliates so they can market to you.</p>
Joint Marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <p>■ Loveless Wealth Management LLC does not jointly market.</p>
